3) The Bulletin Editor reserves the right to edit any notice for style, content and length.



Solving Problems, Tax Issues



#### & How to answer your client's questions.

#### Tax Stuff You Thought You Knew (2 hours)

We've all had those "light bulb" moments when we realize that we've been missing out on a great tax deduction for a client or have overlooked a perfect tax planning opportunity. These revelations come from many sources. Sometimes it's the one really useful piece of information we learn at a seminar, or a colleague mentions something at lunch that gets us to thinking, or we are researching another tax topic and come across something totally unexpected. We'll dissect this complex form line-by-line and determine what all that incomprehensible language means.
